Dear Speaker Pelosi,

Because of your decades-long support of the Friendship House Association of American Indians and the thousands of Native families who access our services, San Francisco's urban Native community is as strong and resilient as ever. As our founder Helen Waukazoo demonstrated, you can arrive with \$35 in hand to an unfamiliar place, forcefully separated from your home and people, and still create a support system where you reconnect with each other and with your traditional ways. Her spirit is evident in the continued growth of Friendship House.

In 2020 Friendship House launched its third community development project – "The Village SF", which will be a new six-floor building next to Friendship House serving San Francisco's 9,000+ American Indians and Alaska Natives. The Village SF will offer medical, dental, behavioral, youth and elder services. Programs will include interim supportive housing, workforce development, urban farming and nutrition. U.S. policy has displaced many Native peoples from their homes, in part due to forced relocation programs. Organizations like Friendship House are leading the way in helping Native peoples in our cities reconnect with their culture, while also providing critical services.

We respectfully request \$4 million to help support the construction cost of The Village SF. Friendship House has secured and continues to secure additional sources of revenue such as a new market tax credit, corporate and philanthropic donations. Friendship House also has a long-term financial viability plan that includes an expansion of its current programs so that they may qualify for reimbursable behavioral health services.

Friendship House, a nonprofit residential substance abuse treatment center established in 1963 to serve Als/ANs arriving in San Francisco as a result of Termination and Relocation policies, is an Indigenous-led organization guided by the belief that our culture is our medicine. Without culture, community connection, or a physical place to call "home," many urban Indians have struggled to hold onto their identity. We believe that every urban Indian deserves a community that centers their health and cultural needs.

While the COVID-19 pandemic has brought to light the greater disparities between Native peoples and the broader population, it has also shown us what is possible when Native people are provided with the resources to address needs in their own communities. As vaccines were rolled out, Native Americans had the highest COVID-19 vaccination rate of any other demographic in the country. Success rates increase when people receive care and information from their own community.

More than 70% of Al/ANs in the United States live in urban areas. In California, nearly 90% of Al/ANs live in or near cities. And yet, urban Indians remain largely invisible and lack access to critical health services and economic opportunities — in large part because urban Indian organizations have historically been underfunded and undervalued.

In San Francisco, AI/ANs are 17 times more likely to be unhoused, have the highest unemployment rate, and have the lowest homeownership rate. With our partner Native-led organizations, we have been providing a continuum of services that build resilience by providing evidence-based programming, incorporating traditional ceremonial practices, and fostering reconnections with family and community. For example, Friendship House:

- Has served nearly 6,000 clients recovering from substance abuse via two residential treatment centers since 1963;
- Supported 500 children, youth, and young adults with academic, wellness, and cultural programming in school- and community-based settings this past year alone;
- Has contracts and/or MOUs with 10 tribes and 14 Indian Health Clinics & Organizations;
- Is expanding the capacity to screen for and reaching out to sex trafficking victims, and provide them
 with comprehensive services (research shows that 84.3% of sex trafficking victims are diagnosed with
 substance use disorders).

Opening its doors in 2025, The Village SF on an annual basis will:

- Serve over 3,700 Native Americans with health/social services and cultural programming;
- Provide medical, dental, and behavioral health services to 2,670 patients;
- Provide program and cultural space for 500 Native youth;
- Provide program and cultural space for 200 Native elders;
- Provide interim supportive housing for 10 Native mothers and their children in recovery;
- Provide interim supportive housing for 10 recovery program graduates pursuing social work;
- Employ 24 professional staff.

The construction of The Village SF will employ over 200 people of which at least 60 will be hired locally.

We are honored to have the support of community, philanthropic and government partners such as San Francisco Mayor London Breed. The Village SF will provide an excellent catalyst for the overall revitalization plan for urban American Indians and Alaska Natives who live in the San Francisco Bay Area, and will result in a vibrant and thriving community, in particular the San Francisco American Indian Cultural District. We hope that you and your colleagues advocate for investing in this critically important work on behalf of all Californians.



U.S. policy has displaced many Native peoples from their homes, in part due to forced relocation programs. Organizations like Friendship House are leading the way in helping Native peoples in our cities reconnect with their culture, while also providing critical services.

Opening its doors in 2025, The Village SF on an annual basis will:

- Serve over 3,700 Native Americans with health/social services and cultural programming;
- Provide medical, dental, and behavioral health services to 2,670 patients;
- Provide program and cultural space for 500 Native youth;
- Provide program and cultural space for 200 Native elders;
- Provide interim supportive housing for 10 Native mothers and their children in recovery;
- Provide interim supportive housing for 10 recovery program graduates pursuing social work;
- Employ 24 professional staff.

The Village SF will provide an excellent catalyst for the overall revitalization plan for urban American Indians and Alaska Natives who live in the San Francisco Bay Area, and will result in a vibrant and thriving community. I am in full support of this bold and culturally driven vision and proposal, and we hope that you and your colleagues advocate for the California Legislature investing in this critically important work on behalf of all Californians.
