Several health centers are seeking funds to convert existing non-clinical space and complete renovations to expand clinical services, one health center is seeking funds for the expansion of their Wellness Center where older adults receive support and participate in group classes for managing chronic diseases, and one health center needs funds to expand security services. In my district, this funding will enable North East Medical Services to buy back up generators for their clinics, since frequent power outages can drastically affect patient care. This project among the many others proposed, supports the critical work that our nonprofit community health centers do on behalf of our most vulnerable populations. These types of infrastructure projects are critical for long term operation but are often difficult to find funding for.
