Re: Letter of Support for Senior Ex-Offender Program Community and Rehabilitation Center Expansion Project.

Speaker Emeritus Nancy Pelosi,

I am writing to support the Bayview Hunters Point Multipurpose Senior Services program titled "Re-Entry Hub: Senior Ex-Offender Program (SEOP) Community and Rehabilitation Center Expansion Project."

San Francisco's jail count has increased exponentially since the pandemic. Averaging more than 800 inmates during the 2020 pandemic to today's jail count of nearly 1200 inmates (April 24, 2024 data), our Department is experiencing an almost 50 percent increase from our 2020 numbers. San Francisco incarceration rates are increasing while funding for programming and infrastructure has not.

Upon hearing that the Bayview Hunters Point Multipurpose Senior Services would be applying for an appropriation grant with your office to create a "Re-Entry Hub: Senior Ex-Offender Program (SEOP) Community and Rehabilitation Center Expansion Project" in the Southeast part of the city, I was eager to support. Expanding re-entry services, especially services targeting the Southeast neighborhoods of San Francisco, is a win for our Department, particularly our Department's jail discharge planners. For the past four decades, the San Francisco Sheriff's Department has been nationally recognized for its rehabilitating programs and deep connection to community-based agencies. The SEOP has been connected to our Department since the late Dr. George Davis founded it in 2000.

The SEOP expansion hub would create a state-of-the-art, brick-and-mortar site for re-entry services in Southeast neighborhoods of Bayview Hunters Point, Vistacion Valley, and Potrero Hill. The Senior Ex-Offender Program (SEOP) Community and Rehabilitation Center Expansion Project would resolve a tremendous capacity and infrastructure problem that our aging population faces.
