The Transportation Authority develops San Francisco's transportation system through our roles as the county Congestion Management Agency and administrator of San Francisco's voter-approved transportation sales tax program.

The San Francisco Golden Gate Ferry Terminal is a vital regional transit hub that has been in continuous operation since 1978. It serves as a primary link between the North Bay and San Francisco, supporting more than 1.5 million annual passengers. These improvements are essential to prevent service disruptions and ensure the continued reliability of our regional ferry network.

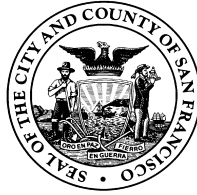
