CalVet has had the privilege of partnering with Swords to Plowshares on the Veterans Support to Self-Reliance (VSSR) pilot—a \$25 million, three-year state-funded initiative designed to meet the needs of aging and high-acuity veterans in permanent supportive housing. Swords to Plowshares not only designed and successfully advocated for the creation of this pilot, but also serves as the lead agency, working in close collaboration with CalVet to implement and refine the model. stability for those who have served. We urge your support of this critical funding request to help bridge the gap and sustain this important progress.
